Enroller Period

Enroller Period: The remainder of the calendar month in which a new Customer, Associate or Director enrolls, plus the entire calendar month that follows. While your enrollees are in their Enroller Period you are compensated for their purchases as shown below.

Post-Enroller Period

There is no time limitation for this compensation period.

Your Compensation	

20% Enroller Bonus: Paid on the QV of all the Customers, Associates and uncertified Directors you enroll.
To Qualify: Be an Associate, Director or above on Auto-ship of \$120 QV*.

6.945% Wholesale Profit: Paid on the QV of all the Customers, Associates, and uncertified Directors you enroll.
To Qualify: Be a Director, or above.

8% Matching Bonus: Paid on the QV of all the Customers, Associates and uncertified Directors you enroll.
To Qualify: Be a Director, or above, on Auto-ship of \$120 QV*. Enroll new Customers or Associates with product totaling \$120 QV for the calendar month.

6% Royalty Override: Paid up to six levels deep (unlimited width) on the QV of all the Directors and above in your organization, and on the QV of all their Customers, Associates and uncertified Directors.
To Qualify: Be a Director or above with a Personal Volume of at least \$120 QV* and Group Volume of \$240 QV for the calendar month.

* or 5 bottles, whichever is less

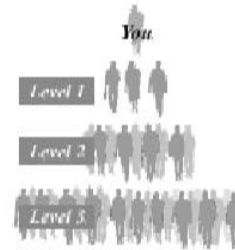

Your Compensation

6.945% Wholesale Profit: Paid on the QV of all the Customers and Associates you have enrolled.
To Qualify: Same as during Enroller Period.

8% Matching Bonus: Paid on the QV of all the Customers and Associates you have enrolled.
To Qualify: Same as during Enroller Period.

6% Royalty Override: Same as during Enroller Period.
To Qualify: Same as during Enroller Period.

The residual income from your Royalty Overrides will grow exponentially as others in your organization duplicate your efforts!

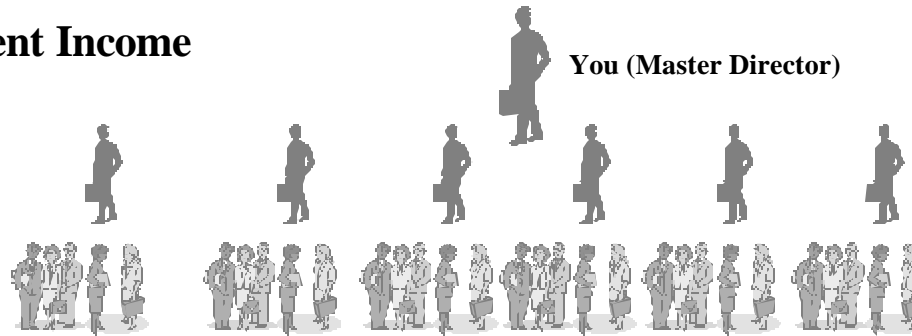

As a **Master Director** you are eligible to be paid 6% Royalty Overrides on the Group Volume of each Director (or above) within your first 4 Director levels, every month. Group Volume is the QV price of combined products purchased that month by all your Directors, plus all their personally sponsored Customers, Associates and uncertified Directors.

The above hypothetical illustration shows what your Royalty Income would be if each First Level Director sponsored 3 Directors whose groups each did \$1,000 QV for the calendar month, who in turn sponsored 3 Directors whose groups did the same, to the 4th Director level. A great Royalty Income from IMPaX simply means a lot of people doing a little!
